

## **Legislative Progression re Voter Registration, Voting, Tabulation**

Fundamental principle for 150 years was voting in community where live in neutral location free of pressure with “check and balance” of two major parties.

**National Voter Registration Act** aka “Motor Voter” 1993; IL 1995 by federal court supervision. Voting still largely at local polling site on Election Day.

- **Mail in voter registration** -- “self-certifying” no requirement to appear before another person, show ID and give oath information is correct.
- **Agency based registration** – DMV, social security, Public Aid, Food Stamps/Snap, IDPH, county health department, township and municipal offices, military recruiting, etc.
- **National Change of Address** – first step toward “nanny state” approach
- **Deputy Registrars largely removed** from process -- began the road to obsolescence.

**Help America Vote Act** (HAVA) 2001 requires new programs procedures in states:

- Provisional Voting – everyone gets a ballot, even in wrong location or not registered
- Voting Information – *late arriving ballots*, “how many ballots do we need to find?”
- Statewide Voter Registration Databases – marketed “to find duplicate registrations”
- Voter Identification Procedures – limited methods and official sources
- Administrative Complaint Procedures – process for the election to “never end.”

**Unrestricted vote by mail** – but still assigned polling place centric

**Early voting in-person 15 days** - mandated sited manipulate placement.

**Daisy-chained DRE voting machines**

**Vote in wrong precinct and in wrong county**

**Election Day registration** – Like having a dinner party and invite the entire country without an rsvp.

- **Electronic poll books** – de facto mandate for election materials to be connected to cloud; post-election evidence no longer defined paper, files denied and images “unavailable.”
- **Printing ballots “on demand”** murky accounting of how many ballots were out there. Not audited list and count each time ballot packet opened.

**ERIC, Inc**– interstate consortium “ensuring efficiency and integrity of voter rolls” created by non-profit funded by Pew Charitable Trust with funds obtained through Soros entities. Pioneering states: Colorado, Delaware, Maryland, Nevada, Utah, Virginia and Washington.

**2017 in Illinois SBE becomes the arbiter of registration updates and duplicates** per ERIC and NCOA. State runs NCOA (maintains “accuracy” of voter lists) on December 1 in even year elections—after election mark those who moved before election.

**State discontinues supplying date of birth** with voter file: name, age, address

**2020 – marked increase in vote by mail** --without poll watchers and challenges permitted

### **Permanent Vote by Mail in 2022**

**NH voting without judges of two parties** (in violation of statute) continues in 2022

**DuPage moves to “vote anywhere”** – mega voting centers and vote by mail marginalize election auditing and access to voter identity. Virtually no meaningful audit: tabulation at a distance, test decks not shown, precinct tapes in DuPage.

### **What does the public think about election integrity?**

- Rasmussen Poll (Dec 2021) 75% of voters believe ID requirement to vote is reasonable”
- 70% of GOP voters say mail-in voting leads to fraud and impacted 2020.
- 70% of GOP voters believe private grant funding is bad for democracy.
