National Voter Registration Act of 1993 – 2d bill signed into law by Bill Clinton. Mandated an honor system for voter registration with "mail in" registration; moratorium on list maintenance 90 days before federal elections; agency-based registrations. Permits use of NCOA for list maintenance.

**Help America Vote Act (HAVA)** – created Election Assistance Commission (EAC) – primarily to move out of Federal Election Commission (FED) and provide funds, equipment certification and guidelines. No governing authority – lies with Dept of Justice, primarily Civil Rights Division and the requirements for bilingual ballots.

**Uniformed and Overseas Citizens Absentee Voting Act (UOCVA)** and **Federal Voting Assistance Program (FVAP)** – combination registration and request for ballot applications. No method of confirming citizenship. Formerly served military, diplomatic corps, Peace Corps, etc. Currently fewer than 40% of voter are military. During COVID, US government called many home, yet UOCAVA voter rose dramatically. Many were using the FVAP postcard state side rather than registering at US address.

<u>Voter List Maintenance</u> – moved, bad addresses, duplicate voters, incomplete records, not eligible – NVRA, federal mail in postcard registration; agency-based registrations, Internet registration. - <u>Citizens Research</u> revealing the massive funding, NGOs and other groups embedded in the local office, EAC, federal agencies in particular Homeland Security/CISA. See the research projects below.
- <u>USPS</u> the US postal service is now the largest precinct in America; all vote by mail and permanent vote by mail. Ballots mailed to every registered voter; ballot not verified as voted by registered voter; skilled care voting at 100+% turnout. Delayed mail in two IL counties

reported of over a month. Mail in bottom half of state goes to St. Louis where postal worker was fired as part of an investigation of holding back ballots. Lake mail goes to Wisconsin.

 <u>Legislation</u> – All mail ballots, permanent vote by mail, expanded early voting, 45 days for voting, Ranked Choice Voting, late arriving ballots, automatic registration at DMV and other agencies.

- **Proposing Audit Standards** Submitting to Election Assistance Commission start to finish forensic audit of all aspects. Poll books, ballot requests, voter verification, ballots issued, ballot counted, ballots spoiled, undervotes, overvotes.

1. The compromising of elections begins with voter registration. NVRA built inaccuracies into the system. Garbage in, garbage out. The greatest bang for the buck is with list maintenance using official government source documents to "help" the local official. IL is a member of ERIC – which is a front to ADD to the rolls. **Microtargeting** -- Building those lists was likely one of the reasons billionaire megadonor George Soros helped found and remains a beneficial owner of Catalist LLC (formerly Data Warehouse), which provides:

innovative, consolidated voter data services in the progressive political marketplace . . . that will allow progressives to realize the advantages of data-driven campaigns that increase the precision and power of fundraising and outreach efforts.

- 2. **Serve as an election worker or poll watcher**, particularly for vote by mail processing. DuPage has been at the center of ending diminishing safeguards.
- 3. **Engage is monitoring and exposing NGOs and dark** money in your local election offices, colleges, high schools, and using PPI to micro target registrations and ballot harvesting. Mission: research and document the relationship between state and local election offices with leftwing entities that are intent on manipulating our elections.

#### Arabella Advisors

Arabella Advisors was founded by Eric Kessler, a former Clinton administration appointee. The current CEO of Arabella Advisors is Himesh Bhise.

### **Zuckerbucks**

Mark Zuckerberg also gives through a network of grant makers under the broader Chan Zuckerberg Initiative umbrella. These include the Chan Zuckerberg Initiative, LLC, a 501(c)(3) private foundation called the Chan Zuckerberg Initiative Foundation, a 501(c) (4) nonprofit called Chan Zuckerberg Initiative Advocacy, and the Chan Zuckerberg Initiative Donor-Advised Fund housed at the Silicon Valley Community Foundation, a 501(c)(3).

<u>The Center for Tech and Civic Life (CTCL)</u> received nearly \$350 million from Mark Zuckerberg in 2020 to influence the outcome of the 2020 presidential election.

<u>US Alliance for Election Excellence</u> is a project of CTCL; announced a new \$83 million project called the US Alliance for Election Excellence – to 'work with' every election office across the country.

# Willard has been asked to answer the following questions:

1. How can we verify that the votes cast with the computer voting machines are accurate? *Audits – real audits-- by independent groups and complete chain of custody are essential.* 

- 2. What can we do to get paper ballots? Many counties still provide paper ballots ans all must do that for mail ballots. *Become engaged with state and national efforts for full comprehensive audits. EIN is developing standards to introduce to EAC and congress.*
- 3. What do you think of early voting? Do all counties in Illinois have early voting? *Yes. Specific statutes differ for larger counties*.
- 4. What action items can we do to ensure there is no fraud? *Be involved; be an election worker, poll watcher, list maintenance volunteer.*
- 5. What types of things are you doing in the area of voting fraud? See above.
- 6. What can be done to stop the following:
  - Man's spouse dies and he votes for her by mail. *Urge families to report deaths. If out of state is it dependent on the family.*
  - Person recently moves and then votes in two different states. We (the IL Voter List Maintenance working group) are addressing this statewide with National Change of Address data purchased for all states. More than 527,000 active voters who filed a permanent moved form with the USPS.
